- b. ISMVL-2021 S. Nagayama reported on the current symposium. There are 61 registrations (authors: 33, non-authors: 28). The number of paper submissions was 46, and 35 papers were accepted.
- c. ULSIWS-2021 M. Natsui reported on this year's workshop. The date of the workshop was changed from the day before ISMVL into the day after ISMVL. The workshop will be held on May 28, 2021. There are six regular talks, and more than 30 people have registered.

3. Future Events

- a. ISMVL-2022 K. Smith reported that the 52nd symposium would be held on May 18 to 20 in Dallas, TX, USA as approved at the 2020 Plenary Session. M. Thornton will serve as Symposium Chair, K. Smith will serve as Program Chair, D. MacFarlane will serve as Local/Publicity Chair, and M. Miller will serve as Financial Chair. She noted that the location of the symposium would be at Southern Methodist University. The paper submission deadline is Nov. 1, 2021 as usual.
- b. ULSIWS-2022 M. Natsui proposed merging the workshop into the ISMVL as a special session. Y. Yuminaka suggested continuing the discussion about the next chair and style of the workshop.
